5. Understand that countries that are very different in other respects now face surprisingly similar migration challenges, which no longer need to divide them into adversarial camps.
6. Understand the experience of migration has evolved in some less positive ways.
7. Understand today's international migrants are, more than ever before, a dynamic human link between cultures, economies, and societies.
8. Understand the skills and knowledge migrants accumulate are instrumental in transferring technology and institutional knowledge.
9. Develop knowledge and critical thinking and writing skills necessary for effective participation in the global community.
10. Understand the mass movement of people from the industrialized and developing countries, as well as the "South-to-South" movement.
