A study of the basic functions, structure, procedures and problems of American state and local government, with an emphasis upon intergovernmental relations. MnTC Goal 5 and 9.

#### C. OUTLINE OF MAJOR CONTENT AREAS

- 1. Federalism---historical and current rules of interaction between federal and state government.
- 2. State political culture---Minnesota as typical of the "moralistic" political culture--evolution of Minnesota politics, decline of the moralist culture.
- 3. Federal policy mandates---unemployment insurance, health care, unfunded mandates.
- 4. State constitutions---including a review of the Minnesota Constitution.
- 5. State institutions---governors, legislatures, judiciary.
- Local participatory institutions---party organization, "grass roots" groups, campaigns and elections--history of the D-F-L and Minnesota GOP.
- 7. State and local bureaucracy--budget process, taxation, bonding issues.
- 8. Education policy---K-12 and the "Minnesota Miracle"; Higher education funding--private colleges, the University of Minnesota (land grant) and the creation of MnSCU.

#### **D. LEARNING OUTCOMES (General)**

- 1. Students will learn the major tenets of American federalism, the role of the states within the federal system, and the relationship between federal and state government.
- 2. Students will learn how the states delegate certain responsibilities to their sub units of local governance---county, municipality, township and how that relationship is maintained and monitored.
- 3. Students will take an active role in learning where they can affect Minnesota public policy in the areas of education policy by being able to locate state and local officials and be able to direct their concerns to the appropriate office or agency for redress.
- 4. Students will consider the efficacy and ethics of redistributive policies regarding state revenues in examining the history of the "Minnesota Miracle" and Local Government aid.
